---

- (1) D.C. Municipal Regulations, Title 30 § 2126 requires that an Operator or Management Services Provider shall not accept any wager on a sports event unless it has received prior approval from the Office of Lottery and Gaming (Office).
- (2) For purposes of § 2126, Attachment A contains the list of Office approved sports events and wager types.
- (3) If an Operator or Management Services Provider would like to offer a new category of sports event or wager type, they must submit a request to the Office using the Category of Wagering Event Request Form (Form). The Form is available for download from the Office's website.
- (4) Any request for a new sports event or wager type must be submitted to the Office at least fourteen (14) days in advance of the proposed date of accepting wagers on such category of sports event or wager type.
